## PURPOSE

The Davidson County Drug Court Program is a diversionary program that provides for the supervision of non-violent offenders with substance abuse problems combined with intensive treatment and other integrated services. The key to making this program successful is Developing Character During Confinement (DC4). We have successfully developed a community that allows offenders to address their chemical dependency and mental health issues as well as make modifications to their criminal behavior.

## HISTORY

In 1995, Judge Seth Norman of the Division IV Criminal Court became aware of a program called "Drug Court" that was attempting to combat the lack of treatment for chemically dependent offenders. The program was offered in the form of Federal grants through the United States Department of Justice. Judge Norman submitted application for funding a drug court program in Davidson County. The Davidson County Drug Court started as an outpatient drug treatment program in 1997 and quickly added an inpatient residential program.



## REFERRAL PROCESS

Referrals for Drug Court must be clients who have felony/misdemeanor offenses, whether in the bound over phase, a probation violation, or both. The offense(s) do not have to be drug related but must have a recent history of **substance abuse along with a mental health diagnoses**. The defendant will need 30 to 45 days of detox prior to placement in the program; this includes jail detoxification.

The defendants should enter a plea in the County of origin and sentenced to Community Corrections or sentenced probation with the condition to be supervised by Davidson County Community Corrections. A transfer order will need to be signed by the sentencing Judge, defendant, and the defendant's attorney if the case originated outside of Davidson County. When referring a client for Drug Court screening, please allow 4 weeks for the completion of the assessment process. When referring a client, please provide the following information: Name, date of birth, social security number, case number(s), County case is pending, current charge and any pending court dates.

The Assessor will contact the referring agency with the status of referral. If accepted in the program and there are no beds available for placement, the client's name will be placed on a waiting list. The client will be set on the docket as soon as there is a bed available, assuming all legal paperwork has been received.

## **Developing Character During Confinement**

The Davidson County Drug Court Program (DC4) consists of a long term residential facility (approximately 18 months in length), intensive outpatient program, and a mental health dual-diagnosis program which operate under the direct supervision of the Division IV Criminal Court in the 20<sup>th</sup> Judicial District of Tennessee (Nashville/Davidson County). Judge Seth W. Norman presides over both Division IV Criminal Court and DC4.

## ELIGIBILITY

This is a voluntary program. The Drug Court will not accept any individual unless the District Attorney General and/or sentencing Judge in the county of the conviction agree to the placement.

- Adult males or females with substance abuse dependency and/or mental health diagnosis convicted of a non-violent felony or misdemeanor in Davidson County.
- Must be capable of and willing to participate in Drug Court Programming.
- Medical and Mental Health History will need to be submitted at the time of referral to ensure the appropriateness of the client for the program.
